

CORRUPTION: Both the payers and receivers of bribes will confidentially pay a fine of the full value of the bribe during a 3-month amnesty. Thereafter, whistle-blower legislation will be enacted where the offender's fine will be 10 times the value of the bribe. The whistle-blower will be rewarded with the full value of the bribe. However, the whistle-blower may be liable for defamation if there is no evidence of corruption.

CHARGED PERSONS: Only the charges and court cases of those convicted will be published. Publishing any such details of innocent and not-convicted persons will attract defamation fines. Fines will be quantified based on the loss of reputation and loss of earnings due to publication.

OPPOSITION COOPERATION: The Opposition should work with the Government in proposing solutions, but they are concerned about snap elections. Therefore, elections can only be called one year in advance.

LIFETIME PENSIONS: The lifetime pension arrangement for politicians will be abolished. Parliamentarians will receive pension contributions to their pension accounts only while they are in office.

PARLIAMENTARY PRIVILEGE: The Privilege that allows politicians in parliament to accuse individuals without consequences will be abolished. Parliament should be the place where exemplary debates and discussions are held, not a place of incivility.

GOVERNMENT CONTRACTS: All government contracts, where the total value is over \$25,000, shall be publically tendered through a fair tender process. The tendering process shall be managed by a non-political tenders committee, most of whose members shall comprise representatives of professional organisations with effective disciplinary sub-committees.

TAXES: Personal and business taxes should be affordable, fair, easy to pay and easy to audit. Therefore, all individuals and businesses will be taxed at 10% of total (gross) income with no deductions. All old debts will be forgiven, and VAT will be abolished.

Dear Resident:

I am Rev. John Wesley Carter and am honoured that you would consider me to be your representative in Parliament.

As I attend prayer meetings across Barbados, a common prayer is for an improvement in the economy and for God to raise up righteous, competent and qualified men and women of God to lead this nation. That time is now.

We need representation that is solutions oriented and depends on God's wisdom. I believe that my background and experience fit me for this task.

I have been involved in church ministry, education and business for the past 50 years. As an educator, I have taught full-time at three secondary schools. I currently teach part-time at a private secondary school and volunteer as a tutor at Her Majesty's Prison, Dodds in their rehabilitation program. I have also tutored at the Wesleyan Bible College, Guyana and Southern Wesleyan University, South Carolina, USA.

In the private sector, I have worked in various management positions and as a consultant tasked with productivity improvements. As a Minister of the Gospel, I have pastored churches in Barbados, Belize, North Carolina, USA and Trinidad and Tobago.

I care passionately about the development and wellbeing of my fellow Barbadians and the people of St Lucy in particular. In this regard, I would like to see: more agricultural land in St Lucy producing food; households planting some food crops; improved road maintenance; development of recreational seaside properties; and heightened ecotourism projects which can provide jobs and opportunities for business development.

Why St Lucy? My wife and I are building our home in St Lucy, to which we expect to relocate soon. Since St Lucy is at the head of Barbados, with its unspoilt beauty, it should lead Barbados' development. I stand ready to assist.

Two years ago, we published workable solutions to the main problems hindering Barbados' development on SolutionsBarbados.com. Some of them are outlined below, but the full list and description is on our web page.

SECONDARY EDUCATION: All students should leave school with at least one marketable skill that they can use to generate income. Therefore, the school curriculum will be revised so that the easier-to-learn practical aspects of subjects are taught during the first 3 years (eg. conversational language & applied science), followed by CXC preparations.

TERTIARY EDUCATION: Evening classes, managed by the BCC and SJPP, will be held at secondary schools. Many of our students are unable to attend the BCC and SJPP due to a lack of space. This is additional space.

None of our diligent students should be denied a UWI education due to a lack of funds. Therefore, UWI tuition will be paid in full for those who obtain 7 CXC General (I and II) and 3 CAPE passes.

AGRICULTURE: Government should share the crop theft risks. Therefore, farmers will be reimbursed immediately for thefts, and an effective praedial larceny section will be set-up within the Police Force to investigate and charge offenders. **Tractor services will be available to small farmers.** Properties with food bearing trees will pay reduced land tax.

WELFARE: Welfare should be available to all, not just to those who complain the loudest. Therefore, all households will receive a small amount of water and electricity each month at no cost. The cost of the amounts above this minimum will be increased to pay for this subsistence amount.

CRIMINAL JUSTICE: Criminals should pay for the cost of the criminal justice system. Therefore, all offenses will attract a fine of 10 times the value of the offence. Maintenance work will be found for those who cannot pay their fines. Prison will be reserved, mainly for violent offenders.

HEALTH: Healthy foods should be affordable. Therefore, all taxes will be removed from healthy foods, and a health tax will be applied to all high-fat, high-salt, high-sugar and high-alcohol products. Those who choose the higher priced unhealthy food will be pre-paying for their future health care.

INSURANCE DELAYS: Property and injury claims must be either settled within 3 months of the incident, or they must be adjudicated by a third party. Insurance companies may be granted additional time to further investigate exceptionally complex claims, including suspected fraud claims.

GOVERNMENT SERVICES: Complaints should be permanently addressed and wastage should be minimized. Therefore, all public (Government managed) services will be developed and delivered to the international quality management standard, ISO 9001.

NATIONAL BANK: A national development bank will be established, primarily to assist small businesses. Transactions can be performed at the various post offices across Barbados, over the Internet, and at ATM's.
